Comments: Amending the 2026 O&M budget to provide watercourse maintenance in-house rather than contractual has an unfavorable impact of \$182,861 on the 2026 budget. Funds originally budgeted for contracting these services is redistributed to various accounts, and the unallocated reserve is to be utilized for additional upfront equipment costs. Based on internal analysis, over a five-year period, these services are expected to save the District approximately \$889,000. This amendment also increases 2026 District headcount from 250 to 253 positions.
