SUMMARY:			
The Commission is requested to authorize the Executive Director to execute on behalf of the District Contract M10005GF03-01, 2024 Private Property Infiltration and Inflow (PPII) Reduction Project – St. Francis Neighborhood, City of Greenfield, to Mid City Corporation (Mid City) in the amount of \$1,044,440. Mid City was the lowest responsible, responsive bidder between the two bids received.			
As outlined in the Statement of Policy, Milwaukee Metropolitan Sewerage District PPII Program (Policy), municipalities can request the District to manage, design, and construct projects on their behalf. The cost of the work and a four percent District management fee are deducted from the municipality PPII Account. In October 2023, the City of Greenfield executed Memorandum of Understanding M10005GF03 with the District, outlining the terms of this agreement to complete PPII design and construction work within the St. Francis neighborhood in Greenfield. This project area is bounded by St. Francis Avenue, Crawford Avenue, South 47th Street, and South 46th Street.			
Mid City will complete PPII reduction work on 24 properties. Of the 24 properties, 21 will receive a full lateral replacement. Of these same 24 properties, 18 will also have the foundation drain disconnected with a sump pump installed. Several unique project site conditions complicate construction and escalate construction costs. Most sanitary sewers within the project area are constructed within a backyard easement, over which many residents built. Additionally, the homes are constructed very closely together, with significant changes in elevation between properties.
