RELATING TO: Review of the 2025 Wisconsin Department of Natural Resources Compliance Maintenance Annual Reports for the Jones Island and South Shore Water Reclamation Facilities

SUMMARY:

The Commission is requested to review the Jones Island Water Reclamation Facility (JIWRF) 2025 Compliance Maintenance Annual Report (CMAR) and to authorize the Executive Director to transmit the JIWRF CMAR to the Wisconsin Department of Natural Resources (WDNR) by June 30, 2026.

Further, the Commission is requested to review the South Shore Water Reclamation Facility (SSWRF) 2025 CMAR and to authorize the Executive Director to transmit the SSWRF CMAR to WDNR by June 30, 2026.

Chapters NR-208 and NR-210 of the Wisconsin Administrative Code require that a CMAR be submitted annually for each wastewater treatment plant. The Wisconsin Administrative Code also requires that the governing body of each publicly owned treatment works review the CMAR for the facilities under its jurisdiction and authorize staff to transmit the report to WDNR. Under the rules, submission to WDNR is required by June 30 of each year for the prior year's report.

The CMAR is essentially a score card that evaluates collection and treatment system performance in different categories. Each category is scored and graded. The results from each category are then combined into an overall grade. The categories and their results for 2025, as currently shown in the WDNR electronic database, are as follows.
