## **SUMMARY (Cont'd)**

Adoption of Commission Policy 1-73.27, Business Continuity Plan, and Revision of Commission Policy 1-77.47, Authorizing the Executive Director to Create Temporary Positions

The proposed new Commission Policy 1-73.27, Business Continuity Plan, authorizes the Executive Director to declare an emergency and invoke the Business Continuity Plan. This policy allows the Executive Director, in the event of a catastrophic loss of normal operations, to relocate operations, retain additional staff, and contract for goods and services, all on an expedited basis. Current Commission Policies do not necessarily permit the degree of flexibility needed in the event of a total and immediate loss of functionality as a District.

The proposed revision to Policy 1-77.47, Authorizing the Executive Director to Create Temporary Positions, authorizes the Executive Director to assign employees tasks that are outside their established job description or department as needed to support continuing District operations. It also authorizes the Executive Director, upon activation of the Business Continuity Plan, to fill temporary positions as may be necessary to alleviate the effects of emergency situations determined by the Executive Director to be detrimental to efficient District operations. The Executive Director will report to the Commission monthly relative to the creation of temporary positions throughout the duration of the Business Continuity Plan.

## **RESOLUTION**
