Award of Contract C05051C01, Edgewood Avenue Near Surface Collector Extension, and Approve Changes in Total Project Costs

The proposed project will construct a 2,300-foot, 72-inch-diameter NSC in Edgewood Avenue. The NSC will start at North Maryland Avenue and extend west to the District's NS-4 Inline Storage System (ISS) structure. It will function as a relief sewer, capturing and conveying excess flow to the ISS during large precipitation events and reduce the risk of combined sewer basement backups.

Under this proposed contract, Super will:

- Install approximately 2,300 feet of new 72-inch-diameter pipe constructed by tunneling.
- Construct three shafts to be used for tunneling.
- Construct two diversion structures.
- Construct a bioswale at River Park.
- Restoration of the construction site.

The low bid received by the District for Contract C05051C01 is less than budgeted, and staff requests to decrease the TPC accordingly.

The duration of the contract is 520 days.

RESOLUTION

Award of Contract C05051C01, Edgewood Avenue Near Surface Collector Extension, and Approve Changes in Total Project Costs

RESOLVED, by the Milwaukee Metropolitan Sewerage Commission, that Contract C05051C01, Edgewood Avenue Near Surface Collector Extension, is awarded to Super Excavators, Inc., in the amount of \$9,545,433, and that the Executive Director is directed to execute a contract on behalf of the District.

FURTHER RESOLVED, by the Milwaukee Metropolitan Sewerage Commission, that the total project cost for Project C05051, Edgewood Metropolitan Interceptor Sewer Extension, is decreased by \$5,933,066 for an amended total project cost of \$11,616,971, and that a corresponding change is made to the total project cost for Project M99001, Allowance for Cost and Schedule Changes.
