Super Excavators made good faith efforts to obtain quotes from S/W/MBE firms for all scopes of work. For concrete, they divided the scope into "flatwork" (streets, sidewalk, curbs) and structural concrete to allow for maximum participation of S/W/MBE firms. They are utilizing a S/W/MBE firm for the flatwork. They received a quote from one S/W/MBE firm for the structural concrete work, but they were also not selected due to higher pricing. For asphalt paving, they did receive a quote from one S/W/MBE firm, but they were not selected due to higher pricing.
